AFFIDAVIT IN SUPPORT

MILDRED CURRY, being duly sworn, hereby deposes and says:

1. I am of sound mind, sane, sober, not under the influence of drugs or alcohol, and am not suffering from any physical impairment affecting my judgment. Further, I have personal knowledge of the facts and documents stated and described herein.
2. I am 41 years old, born on November 24, 1978. I am single and I have no minor children.
3. I am a resident of and domiciled in the State of New York, Nassau County. I currently reside at 1998 Ladenburg Dr, Westbury, NY 11590
4. I am not currently required to pay monthly child support or spousal support.
5. This affidavit is made in support of CBC Settlement Funding, LLC's ("CBC") application for Court approval of the sale/transfer to CBC of certain structured settlement payment rights due to me under a structured settlement agreement.

7. That, as a result of automobile accident, I became entitled to receive certain structured settlement payment rights, *to wit*, a lifetime monthly payment of \$1,098.24 beginning May 1, 2013 with a 2% annual increase. A lump sum of \$50,000.00 every 5 years beginning November 24, 2023 through and including November 24, 2033.

8. That, on or about July 14, 2020, I signed a Sale and Assignment Agreement with CBC to sell a portion of the Periodic Payments. In particular, pursuant to the Sale and Assignment Agreement, I have agreed to sell my interest in the following Periodic Payments: One (1) lump sum payment of \$50,000.00 payable on November 24, 2023. One (1) lump sum payment of \$50,000.00 payable on November 24, 2028. One (1) lump sum payment of \$50,000.00 payable on November 24, 2033. (the "Assigned Payment").
9. That, in consideration for the sale and transfer of the Assigned Payments, I will receive the gross amount of \$90,500.00 from CBC. I understand that I will be giving up my right to receive the Assigned Payments in the future in exchange for a lump sum payment from CBC.
10. I understand that the Court must grant permission and approve the sale and transfer of the Assigned Payments to CBC.
11. The money I will receive from CBC will allow me to purchase a home. This will financially help me to not have the burden of worrying about rent which can increase annually.
12. I strongly and verily believe that my decision to sell and transfer the Assigned Payments is in my best interest and that the funds I receive from this transaction can be better used today to provide for the foregoing, rather than for me to wait to receive the full value of payments several years from now.
13. I have considered other means of raising cash and, after weighing the available options, have determined that this transaction is the best course for me. This transaction will provide me with a way to improve my life and decrease the daily stress and anxiety which I currently am going through and allow me to better my life, as well as my families through building this addition to our home.
14. For these reasons, I feel it is in my best interest to sell the Assigned Payments to CBC, Inc. in exchange for an immediate lump sum payment.
15. I was provided with and have carefully reviewed copies of (i) the Sale and Assignment Agreement; and (ii) New York Disclosure Statement, as required by New York law. I carefully reviewed the Sale and Assignment Agreement and Disclosure Statement and fully understand all of the terms set forth therein.
16. In accordance with New York State law, I was provided with written disclosure statements at least ten (10) days prior to signing the Sale and Assignment Agreement. I hereby acknowledge and agree to its contents.
17. As part of the separate written disclosure, I have been advised to seek independent professional advice in connection with the transfer. Accordingly, I have waived such right to receive such independent professional advice.

18. I understand the nature and terms of the transaction. I am entering into the transaction with CBC of my own free will and volition, and without reservation, duress or undue influence.
19. There are no additional beneficiaries under the annuity policy that would qualify as interested parties to this action entitled to receive notice under New York law.
20. Based on the foregoing I respectfully request that the Court find that this transfer is in my best interests, grant the Petition of CBC, and authorize the sale and transfer of the Assigned Payments.
21. I have not previously filed a petition to transfer payment rights under the structured settlement
