

ORDER TRANSFERRING STRUCTURED SETTLEMENT PAYMENT RIGHTS

Considering the foregoing Ex Parte Petition for Transfer of Structured Settlement Payment Rights it is Ordered:

1. The annuity payment transfer is granted.
2. Seller received a disclosure statement including the discounted present value, as required under La. R.S. 9:2715 B(2), and independent professional advice regarding the implications of the transfer as required under La. R.S. 9:2715 C (1)
3. All costs of Court have been paid by buyer as required under La. R.S. 9:2715 B(2).
4. This order does not contravene applicable law or give effect to the transfer that is invalid under applicable law as required under La. R.S. 9:2715 G and La. R.S. 9:2715 I.
5. The Structured Settlement Obligor, Annuity Owner and/or Annuity Issuer, their successors and assigns, and Seller have presented no evidence that the assigned payments have previously been sold, assigned, encumbered, or otherwise pledged, and Seller represents that Seller has all rights, title, and interest in the Assigned Payments with full authority to make this transfer to Buyer and that Seller has not otherwise sold, assigned, encumbered, or pledged the Assigned Payments.
6. Seller is entitled to receive payments from a Structured Settlement Agreement issued by Prudential Assigned Settlement Services Corporation, with annuity policy number SQ000039178 and Seller has agreed to transfer the entire sum and all payments to the Buyer.<sup>6</sup>
7. Annuity Owner, Structured Settlement Obligor and Annuity Issuer are hereby directed to deliver and make payable to Buyer all payments, lump sum and periodic, under annuity contract number SQ000039178, regardless of whether any Seller is living.
8. All assigned payments shall be made payable to and delivered to Buyer/Transferee at the following address:

9. Annuity Owner, Structured Settlement Obligor and Annuity Issuer shall change the designated beneficiary under the annuity for the Assigned Payments to BUYER and no person or entity other than BUYER shall have the authority, upon written notification to the Annuity Owner, Structured Settlement Obligor and Annuity Issuer to change the beneficiary for the Assigned Payments due under the Structured Settlement Agreement. Buyer shall send this Order to the Annuity Issuer, the Structured Settlement Obligor and/or the Annuity Owner and the Structured Settlement Obligor and/or the Annuity Owner shall direct and Annuity Issuer shall issue a formal acknowledgment letter of the transfer within ten (10) days of the date of the receipt of this Order of Transfer that is not limited to but shall include acknowledgement that the Assigned Payments shall be unconditionally made to Buyer at 361 San Francisco Street, San Juan, Puerto Rico 00901 and that Buyer has been made the beneficiary of the same payments, and that Buyer shall be the only person or entity with the authority to change the name and/or address of the beneficiary of the Assigned Payments. The formal acknowledgement letter shall be delivered to Buyer at 361 San Francisco Street, San Juan, Puerto Rico 00901.
10. Pursuant to La. R.S. 9:2715, by making and delivering the Assigned Payments to Buyer as set forth in the preceding paragraph, Annuity Issuer, the Structured Settlement Obligor and/or the Annuity Owner will be discharged from all liability for the Assigned Payments.
