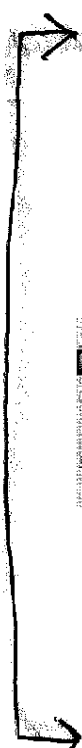

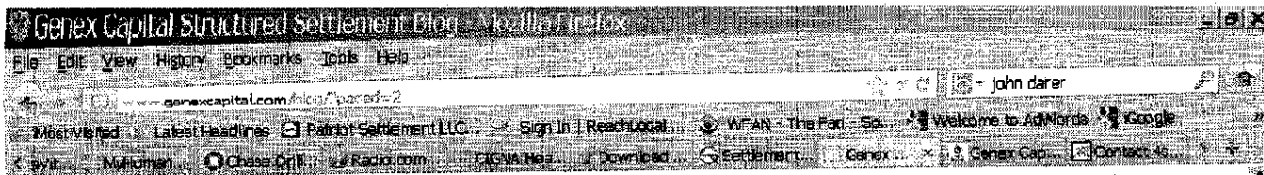

In all actuality, no one can predict the future, but structured settlements could certainly begin to disappear too.
