In April 2011, in accordance with the BBB Code of Advertising, BBB reviewed the web site of Sovereign Funding Group and requested they substantiate the claims they are "a nationwide industry leader, that they are "offering higher lump sum payments," and that they offer "vastly superior customer service." The company was asked to provide comparative data regarding their competitors which supports those claims of superiority. In response, the company made a number of changes to the content of their web site, but in July 2011, the new text continued to make claims of superiority for which BBB also requested substantiation, modification or discontinuance. The company did not respond to that request.
